Earlier this year we published the merger of Descol sports surfaces-Deventer and Sika Nederland B.V.-Utrecht; both part of the Swiss multinational Sika AG. The merger was a logical next step in years of intense collaboration. This merger strengthens the joint markets and internal efficiency.

For you as our relation this means:

### **Sika Nederland B.V. now has two locations:**

- Location - Utrecht, remains the same for Sika relations at the Zonnebaan 56 in Utrecht. Address, telephone and website ([www.sika.nl](http://www.sika.nl)) unchanged.
- Location - Deventer; the location from which the Pulastic® team continues to operate. Address at the Duurstedeweg 7 in Deventer remains unchanged. The website address has changed to [www.pulastic.com](http://www.pulastic.com).

### **Naming**

As of October 1st, 2014, you will see the name Sika Nederland B.V. in all publications. The brand Pulastic® sports flooring is now possessed by Sika Nederland B.V. This newsletter is an example of the new communications. The logo Pulastic® is unchanged, the address at the bottom has been modified.

### **Same contacts**

Your dealings with Sika Nederland B.V. location Utrecht and location Deventer remain unchanged, as well as the telephone numbers. However you will notice that the receptionists of the Deventer location will announce with "Sika Nederland" now.

### **Introducing SAP jointly for both venues**

The introduction of our new accounting system (SAP) will be as from November 3rd. Unfortunately there will be no or very limited deliveries possible a number of days during the transition to SAP. We advise to order ahead before the SAP transfer will take place.

This means:

- For location Utrecht: October 31st closed and November 3rd no deliveries possible.
- For location Deventer: October 27th, 28<sup>th</sup>, 31st and November 3rd no deliveries possible. On October 29<sup>th</sup> and 30th only limited deliveries will be possible for orders received before October 23<sup>rd</sup>.
